## FOR YOUR FUN & SAFETY

### HERE ARE THE MC MOTORSPORTS PARK (MCMP)/PMP RULES:

1. Obey all posted rules.
2. NO ALCOHOLIC beverages.
3. Parents or guardians are responsible for the action of their minor children under the age of 18 at all times.
4. No bicycle or motorcycle pit riding is allowed. ATV/MUV's may idle in first gear between the rider's pit and the venue entry.
5. No minor under the age of 16 may operate a "golf cart" type vehicle on the premises at any time.
6. Minor participant must be accompanied by a parent or legal guardian at all times.
7. An original parent signed minor release form must be on file prior to any minor using any venue at MCMP/PMP.
8. All persons entering MCMP/PMP must sign a daily waiver.
9. MCMP/PMP does not provide medical insurance for spectators or participants. Riders, spectators, and guardians are responsible for medical insurance.
10. Minimum safety gear required – D.O.T. or Snell approved helmet, goggles, gloves, long sleeved shirt, long pants and boots above the ankle. All Minors must wear a chest protector vest.
11. All participants must have a valid MCMP/PMP user I.D. card to gain access to ride.
12. All ATV's must have a lanyard type kill switch in use.
13. All Motorcycles and ATV/MUV's must be able to pass a MCMP/PMP technical inspection that includes at a minimum – throttle that returns to the throttle stop, safety balls on the end of levers, properly functioning front and rear brakes.
14. MCMP/PMP is located in the desert and dangerous desert wildlife may be present.
15. Riders are responsible for their actions of their pit crews – No fighting or unacceptable language will be tolerated.
